### **RIDE CONNECTION:**

1. Overall Ridership for E&D: As of August 2020, the monthly average ridership for E&D services decreased by 42.8% compared to the previous year. Part of this can be attributed to programs being phased out. The main impact to ridership has been the COVID-19 global pandemic.

Notable decreases in ridership for the TriMet Volunteer programs at Clackamas Consortium by 54.1%, Metropolitan Family Services by 57.6% and Ride Connection East by 51.2%.

Other programs experienced noticeable gains in ridership, such as Metropolitan Family Service's STF program by 48.8% (128 trips), Ride Connection Beaverton/Hillsboro's Central RideAbout program by 147.7%, Ride Connection Wa/Forest Grove's WaCo DAVS program by 902.9%, and Urban League's N/NE RideAbout by 473.9%.

2. Total Costs: Monthly cost decreased in September 2020 by 21.3% compared to the previous year. The distinct cost decreases occurred for the TriMet Volunteer programs at Clackamas Consortium by 31.7%, Metropolitan Family Services 4.6%, and Ride Connection East 50.8%.

Noteworthy monthly cost increases occurred in the STF program at Metropolitan Family Service by 99.9% and Ride Connection Beaverton/Hillsboro by 230.4%.

3. The network Cost Per Trip (CPT): As of September 2020, the network CPT increased by 37.47% from the previous year; from \$21.69/trip to \$29.81/trip.

- 6. Referral Sources. There were 5 referrals in September 2020. No referrals were from new agencies or new sources at agencies with which a relationship has already been established, 0 referrals were the result of our travel options counseling efforts.
- 7. School Program. No received training during the month of September. There were 0 trips taken as a group, 0 one-on-one trips. 0 teachers and support staff reported 0 hours of training due to Covid-19.


# **SANDY AREA METRO (SAM)**

- 1. COVID and wildfires greatly impacted ridership in September. Ridership patterns (typically lower in September) continue but remain at lower numbers than 2019. Overall, ridership was 47% lower than that of September 2019.
- 2. SAM Gresham was 44% lower with 4,350 rides in September 2020 as compared to 7,763 in September 2019. Estacada, suspended due to wildfires, was down 62%; 2019 ridership was at 925 compared to 348 riders in 2020. The Shopper Shuttle, also suspended due to wildfires, was down 68%, providing 284 rides in 2020 compared to 892 in 2019.
- 3. Elderly and Disabled rides decreased slightly by 15%. Ridership in 2019 was 60 passengers while 2020 had 51 passengers. SAM *rides* was down 36%, providing 602 rides in September 2020 compared to 938 in September 2019.
- 4. SAM staff continue to procure COVID-19 related items for vehicles such as added fold away seats for SAM rides vehicles and professionally installed germ guards.

- 5. The bus barn project, which saw some delays due to smoke, is now in the last few weeks. A few items remain on the punch list and should be complete by the end of November.
- 6. The bus wash is complete, and the wash equipment has been completely renovated.

### **SOUTH METRO AREA REGIONAL TRANSIT (SMART)**

Ridership for both fixed route and demand response continue to rebuild slowly from COVID-19. Fixed route ridership in September was down 7% while demand response ridership increased by 14% compared to last month.



## **CANBY AREA TRANSIT (CAT)**

 Ridership continues to remain below the prior year due to the pandemic. In addition wildfires caused a further loss of ridership as many of the Cities residents chose to evacuate. During the month of September total CAT ridership was down by 43.1% from the previous year. During the same time period Demand Responsive trips were down by 62.5% and fixedroute was down 38.8%.

- CAT has not reduced service hours or levels during the COVID-19 or during the wildfires. Bus capacity has been decreased to accommodate social distancing policies and policies including regularly cleaning and mandatory masks have been implemented.
- 3. During the month of September CAT charged no fares on fixed route or Dial-a-Ride.
- 4. In August CAT provided 290 Saturday rides on both fixed-route and Demand Response. These rides are paid for with STIF revenue.

## **SOUTH CLACKAMAS TRANSIT DISTRICT (SCTD)**

- SCTD has continued to maintain service hours from pre-Covid-19 levels. Bus capacity has been decreased to comply with the State of Oregon's social distancing regulations, and other precautions have been maintained to limit the spread of COVID, such as face covering requirements, providing hand sanitizers for customers, nightly disinfecting of vehicles, and plexiglass shields to help protect drivers.
- 2. Total SCTD system ridership in September 2020 was down compared to the previous month, by 34%. Ridership was affected due to COVID related declines from the past few months and the unprecedented wildfires that hit our region, which led to the evacuation of The City of Molalla for several days. SCTD provided over 1,845 rides for the month, with the Clackamas Community College route providing over 63% of all rides.
- 3. Elderly and disabled ridership was down in September over the prior month, by 22%, with 338 rides for the month.
- 4. Saturday service provided an average of 50 rides per day. For our city route, 20% of the total Saturday rides on this service were taken by E&D riders.
- 5. During September, SCTD continued to not charge fares on all three routes, due to COVID-19.

### MT. HOOD EXPRESS

- 1. September was another tough month for the Mt Hood Express with various fires throughout Clackamas County. Year over Year rides are still down significantly (67%), but we are hopeful that many riders will return this winter for outdoor recreational activities. Total E&D ridership was down 53% year over year. These ridership trends seem to be comparable to other transit systems in the Portland Metro Area at this time.
- 2. The Mt Hood express has continued to run two buses during the busiest hours on Friday, Saturday, and Sunday to ensure no person is left behind. The funding for the extra drivers and buses will be covered with CARES ACT funds that were awarded to Clackamas County.
- 3. The Mt Hood Express and Village Shuttle service remain fare free at this time.
