#### RIDE CONNECTION

1. In April 2022, Ride Connection provided 13,705 rides. This is a 12% increase over April 2021. This increase can be attributed to the continued re-opening of programs and activities during the COVID-19 pandemic. Ride Connection and partner organizations experienced increased ridership, over the previous year, as more customers begin to re-use the services. Ride Connection programs with increased ridership in April 2022 include Title XIX Non-Medical, Central Beaverton RideAbout and the King City Shuttle.

Partners with increased Ridership include Clackamas County Senior Centers, Urban League, and David's Harp. Metropolitan Family Services and Neighborhood House increased ridership across all programs.

- 2. Total Costs. The average total monthly cost for Ride Connection in April 2022 was \$553,948. This is a 13% increase from the previous year. Increased costs can be attributed to high ridership demand and reduced volunteer drivers. Volunteers continued to opt out of driving due to the COVID-19 pandemic.
- 3. The Network Cost Per Ride. The average cost per ride for Ride Connection was \$40.42 in April 2022. The cost per ride decreased slightly from the previous month. However, due to the COVID-19 pandemic, programs continued to have high costs per ride. These programs include STF Service, King City Shuttle, and WaCo DAVS. Partner programs with high costs include MFS's STF Service, Neighborhood House's SW Shuttle and Impact NW's Cherry Blossom program.

### **RIDEWISE**

1. Service Delivery Analysis. A total of 51 persons were served through RideWise's one-on-one, classroom, group and trip planning by phone/mail training. Nine individuals successfully exited out of one-on-one travel training with two persons whom were prior participants returned to learn a

new route. There was a 900% increase, in successful customers, for the same time period last year due to the COVID-19 suspended in-person training.

- 2. Under the age of 60, a total of nine persons successfully exited out of the one on one travel training with an average of 12.58 training hours.
- 3. Outreach. The RideWise program continues to increase awareness of the program by attending resource fairs, meeting with agency professionals, mailings and presentations at staff meetings, etc. There were no onsite events held, but the following presentations were given virtually:
  - Beaverton School District Parent Resource Fair (virtual)
  - Lake Oswego High School Career Night (in-person)
  - NWRESD Parent Night (virtual)
  - Holladay Park Plaza (virtual)
  - Portland Public Schools Resource Fair (virtual)
- 4. Ride Ambassador Program. There were zero volunteer hours recorded for Rider's Club events, committee meetings or outreach due to COVID-19. This activity remains suspended.
- 5. Riders' Clubs. There were no activities held this month due to COVID-19. This activity remains suspended.
- 6. Referral Sources. There were 18 referrals in April 2022. Two referrals were from a new agency, or new sources at agencies, with whom a relationship had already been established and there were no referrals for our travel options counseling efforts.
- 7. School Program. 270 students received training during the month of April. There were 3,715 trips taken as a group and 375 one-on-one trips. 96 teachers and support staff reported 1,623 hours of training.



# SANDY AREA METRO (SAM)


1. Ridership took a dip in April 2022 as compared to April 2021 and especially compared to pre-COVID-19 levels. Ridership was significantly rising on the Estacada and Shopper routes until COVID-19. Staff will

- attend a National Transit Conference in early May to better understand transit in a post COVID-19 environment.
- 2. Staff are currently focused on capital projects, returned ridership and new technological options.
- 3. Transit sent an application and began working with PGE on the Fleet Partnership Program to begin the process of transitioning the bus barn infrastructure to support an electric fleet.
- 4. The RFP process began in January to replace DoubleMap, which has come to a close. The selection committee selected a vendor to whom an "Intent to Award" will be issued.



### **SOUTH METRO AREA REGIONAL TRANSIT (SMART)**

1. Data for April indicates average ridership as compared to total ridership for the fiscal year. While some travel patterns for commuters, such as hybrid work schedules, seem permanent, SMART will be evaluating how to most efficiently serve customers through an upcoming master planning process. The outreach for the master plan will begin in the summer and work to understand how customer needs have changed as the COVID-19 pandemic levels off or ramps down.



- 2. SMART is built on the foundation of integrating safety in every aspect of operations. In 2019, the Federal Transit Administration (FTA) publicized new safety requirements. In a partnership with ODOT, SMART created a Public Transportation Agency Safety Plan (PTASP) that combined current safety systems and aligned them with the new requirements. In early 2022 the FTA brought forward new guidelines to add to our PTASP.
- 3. To meet the new guidelines, SMART will be forming a Safety Committee to identify and recommend risk-based mitigations to reduce the likelihood and severity of consequences through our safety risk assessment. An updated Risk Reduction Program will be implemented to provide assault

mitigation infrastructure and technology on buses. Lastly, SMART's Safety Training program will be aligned with federal guidelines to give employees the proper tools for de-escalation and passenger safety.

## **CANBY AREA TRANSIT (CAT)**


- 1. Ridership in April held steady and continues to increase from the previous year. Ridership continues to improve overall, though tends to be slow due to COVID-19 slowing riders returning to the bus.
- 2. During the month of April, total CAT ridership was up 9.7% from the previous year. During the same time period Demand Responsive trips rose 48.9% and fixed-route was up 4.0%.
- 3. In April, CAT provided 516 Saturday rides on both fixed-route and Demand Response. These rides are paid for with STIF revenue.
- 4. This month, CAT's city circulator provided 765 rides. This service is also funded by STIF dollars.

## **SOUTH CLACKAMAS TRANSIT DISTRICT (SCTD)**

- 1. SCTD has continued to maintain service hours from pre-COVID-19 levels. While masks are no longer a requirement to ride public transit, SCTD continues to make face coverings available to both riders and drivers who would like wear one. Other precautions have been maintained, such as providing hand sanitizers for customers, nightly disinfecting of vehicles and plexiglass shields were installed to help protect drivers.
- 2. Total SCTD system ridership in April 2022 was down slightly compared to the previous month by 9%. Compared to the previous year, same period, ridership declined by about 12%. SCTD provided 2,221 rides for the month with the Clackamas Community College route providing over 68% of all rides.
- 3. Elderly and disabled ridership remained relatively the same in April compared to the previous month, with 268 rides for the month.
- 4. Saturday service provided an average of 33 rides per day. 15% of the total City Route trips on Saturday were taken by E&D riders during the month of April.

#### MT. HOOD EXPRESS

- 1. April was a very solid month for the Mount Hood Express (MHX) as ridership numbers were above pre-pandemic levels. Ridership numbers were up 68% from FY2020-2021.
- 2. Mountain recreation activities were given an extended season with unusually high amounts of new snow dropping through April. The summer recreation season is going to get off to a later start than normal, which may cause the MHX to see lower ridership numbers in May and June.
- 3. We continue to see a slow recovery of ridership toward pre-pandemic levels.
