RIDE CONNECTION

 Overall Ridership for E&D. In October 2022, Ride Connection and partner organizations provided a total of 15,907 rides. This is a 27% increase from October 2021. Increases can be attributed to the re-opening of centers during this phase of the COVID-19 pandemic as well as the return of group rides. Programs with significant ridership increases include Title XIX Non-Medical, STF Service, General Public and the King City RideAbout.

- 2. Partner organizations also increased ridership in October 2022. Clackamas County Senior Centers, David's Harp and MFS STF Services had notable ridership increases. Other notable increases include Neighborhood House's SW Shuttle Service and Urban League's shuttle. Ridership decreased in some programs such as MFS's N/NE Shuttle and Impact NW's STF Service.
- 3. Total Costs. The average total monthly cost for the Ride Connection network was \$703,772, which is a 52% increase in costs compared to the previous fiscal year. High costs are attributed to inflation, fuel prices and cost of living increases. Additionally, volunteer participation is low compared to pre-pandemic, which affected the overall costs for the Ride Connection network.
- 4. Network Cost per Ride. The average network cost per ride in October was \$44.24. This is a 19.6% increase from the previous fiscal year. Restrictions such as volunteer participation, group rides and center closures by the COVID-19 pandemic contributed to the high cost per ride. Partner programs with high cost per trip include Providence ElderPlace and MFS's N/NE Shuttle. Some partner programs experienced a decrease in cost per ride including Impact NW's STF Service and Clackamas County's Transportation Reaching People.

RIDEWISE

- 1. Service Delivery Analysis. A total of 127 persons were served through RideWise's one-on-one, classroom, group and trip planning by phone/mail).
- 2. A total of 11 individuals successfully exited out of one-on-one travel training, five of whom were prior participants, returned to learn a new route. There was a 15.4% decrease of successful customers over the same time period from last year.
- 3. Under the age of 60, a total of 8 persons successfully exited out of one-one travel training with an average of 13.41 training hours per person.
- 4. Outreach. The RideWise program continues to increase awareness of the program by attending resource fairs, meeting with agency professionals, mailings and presentations at staff meetings. There were no events held during this month.
- 5. Ride Ambassador Program. There were no volunteer hours recorded for Rider's Club events, committee meetings or outreach due the program being suspended due to Covid-19 and staffing.
- 6. Riders' Clubs. There were no events to report this month. The program remains suspended.
- 7. Referral Sources. There were 19 referrals in October 2022 with 14 referrals from agencies, or new sources at agencies, with whom a relationship had already been established. Two referrals were the result of our travel options counseling efforts.
- 8. School Program. 338 students received training during the month of October. There were 3,824 trips taken as a group and 47 one-on-one trips. 126 teachers and support staff reported a total of 2,296 hours of training.

SANDY AREA METRO (SAM)

- 1. Overall October ridership was 13% higher than October 2021. SAM-Gresham provided 5,724 rides, an increase of 15.01% from last year. SAM-Estacada provided 456 rides, a 6.3% increase. The Shopper Shuttle increased by 27.89% providing 509 rides.
- 2. SAM rides did have a slight decrease of 8.7%, compared to October 2021, which is probably due to a driver shortage. Elderly & Disabled rides, however, had a dramatic increase of 143.5% compared with October 2021.
- 3. SAM rides provided transportation to several of the City's holiday events, including the tree lighting, the Shortest Day Walkway and the Holiday Happy Hour at Meinig Park.
- 4. SAM completed the annual on-board surveys in October and provided a great deal of information on the ridership as well as their needs. Surveys were done on fixed routes as well as dial-a-ride. 52.63% of respondents ride almost daily, with 23.16% riding 3-4 times a week. Commuting to work was the number one reason for using transit (48.89%) followed by recreation/social at 28.89%. Ridership is primarily Sandy residents (60%) and the largest age group is 30-44 years old (31.58%). Over half of the ridership (56.18%) earn less than \$20,000 a year, 84.95% do not own a car and 41.27% would not have made the trip if public transportation was not available.

Below are comments from the rider survey that provide a good summary of many of all comments:

"While none of the questions applied directly to the bus drivers, they are the 'butter on the bread' of the transit system. They educate new users, help tourists navigate, seamlessly accommodate to the very wide needs of public transportation users, respond quickly to adjustments in schedules, road construction, traffic problems or passenger's issues, offering friendly reminders of the safety rules in place for all riders. Beautiful buses and convenient schedules are great, but without responsible drivers there wouldn't be a transit system."

"SAM has allowed me to take a part-time job in Sandy as supplemental retirement home. Hugely appreciated!"



- 2. The City is currently working with all of the Clackamas County providers on a collaborative project to provide a one-stop webpage for transit needs in the County. The webpage will have trip planning capabilities and provide information on all of the available transit options including paratransit and demand response.
- 3. The City participated in the Estacada Transportation Plan update. Transit options that allow transportation between rural cities for goods and services is essential. SAM appreciates the long-standing partnership between Estacada and Sandy and looks forward to the published Transportation Plan.

SOUTH METRO AREA REGIONAL TRANSIT (SMART)

- 1. SMART conducted a bus roadeo and training to increase driver awareness of surroundings and improve driving skills.
- 2. SMART summarized community engagement conducted through the summer for the Transit Master Plan update.
- 3. A demographic survey was conducted in October to identify customer needs and where SMART can improve in serving the community sufficiently and equitably.
- 4. Dial-a-Ride programs held a continued increase with approximately 60% of pre-COVID pandemic ridership returning.



CANBY AREA TRANSIT (CAT)

- 1. Ridership in October increased from the prior year. The ridership appears to have reached a point where it is holding fairly steady will small shifts up and down.
- 2. During the month of October total CAT ridership was up 40% from the previous year. During the same time period Demand Responsive trips rose 17% and fixed-route was up 45%.
- 3. In October, CAT provided 471 Saturday rides on both fixed-route and Demand Response. These rides are paid for with STIF revenue.
- 4. In October, the Canby Loop provided 1,308 rides. This service is funded by STIF dollars.


SOUTH CLACKAMAS TRANSIT DISTRICT (SCTD)

- 1. Total SCTD system ridership in October 2022 increased 10%, compared to the previous month. SCTD provided over 2,000 rides for the month, with the Clackamas Community College route providing 38% of the rides.
- 2. Elderly and disabled ridership was up slightly in October, at 3% over the prior month, with 225 rides for the month.
- 3. Saturday service provided an average of 41 rides per day. 4 percent of the total trips on Saturday's were taken by E&D riders during the month of October.

MT. HOOD EXPRESS

1. October showed a good increase in ridership numbers from FY2022, but are still falling slightly short of pre-Covid ridership numbers.

- 2. With nice weather through October, we had higher ridership than usual as we are heading into our slower season before the rush of winter recreation.
- 3. We continue to see a slow recovery of ridership and, based on ridership trends, we are hopeful that the winter recreation period will help us regain full ridership numbers.
