5. Background

At its February 27, 2019 meeting, the Board approved Resolution 19-02-14, authorizing award of a contract to SWI in the amount of \$2,697,123 for construction services, and a \$269,712 change order allowance (10%) for the Cleveland MAX station operator break facility and signal and communications building (Project). To date, SWI has completed approximately 80% of the civil, buildings, and site work, and anticipates completion of the Project by mid-October 2020 (excluding the two-year landscape maintenance obligation).

Historically, a 15% change order allowance has been typically used for remodel work due to the uncertainties inherent in remodeling work, although TriMet has set an aspirational goal of 10% for change orders. Notwithstanding those considerations, the current forecast shows

that an additional 5% (\$135,000) change order allowance will be necessary for SWI to successfully integrate and upgrade the existing 30-year old civil and signal systems with current technology and safety systems.

6. Procurement Process

The contract was procured via a competitive Invitation to Bid process.

7. Diversity

In its bid, SWI expected to utilize certified DBE subcontractors for 8.89% of the work on the project. Currently, SWI is achieving approximately 8.04% certified DBE subcontractor participation. Subcontracting opportunities with DBE Certified firms is limited due to the specialized nature of train signaling and communications work.

8. Financial/Budget Impact

The increased contract amount is included in the FY2021 capital program budget.

9. Impact if Not Approved

TriMet could delay making any additional change orders beyond the already authorized amount. This option is not recommended because the additional work is clearly needed and TriMet will eventually require additional contract authority to pay for the anticipated change orders. Failing to provide this additional contract authority now could result in significant delays in completion of the Project.

WHEREAS, by Resolution dated October 25, 2017, the Board adopted a Statement of Policies requiring it to approve goods and services contracts obligating TriMet to pay in excess of \$1,000,000;
